# IALHA Eligibility and Benefits of Membership

**Life-time Membership** is a full membership that is perpetual. The person must own an IALHA registered horse at the time of application, have paid all fees and be over 18 years of age. Individuals and married couples are eligible. Non-spouse partners or business entities are not eligible.

**Full Membership:** Member must own an IALHA registered horse, have paid all fees owed and be 18 or over. The following are all annual memberships and expire **December 31<sup>st</sup>** of the current year.

**Individual Full Membership:** This membership is for any individual who owns a registered IALHA horse. One name is printed on the membership card and the member has full benefits as described below. **For one person who is a shared owner** (two or more persons must be joint owners of one registered horse) and for Full Membership purposes shall be considered one member. They must designate the person who receives the Full Membership privileges. Each IALHA registered horse may represent only one Full Member.

**Partner Membership:** This is a Membership with additional benefits for a second named person. The person designated primary person receives the Full Member benefits and must own or share ownership of a registered IALHA horse. The second person can enjoy discounts, show participation, awards etc, but will not be eligible to hold an elected position. Two cards will be issued, one for each individual. Only one mailing, magazine, etc. will be sent.

**Business Membership:** A business entity or business owner must be the owner of a registered IALHA horse. The business must select one person as **primary person**. The designated person receives the Full Member benefits as outlined below. One card will be issued with the business name on the first line and the **primary person** (Full Membership benefits). No one else may receive benefits, but owners may add additional memberships for each additional registered horse owned, not to exceed five (5).

**Associate Membership** Member need not own a registered IALHA horse. This is a great choice for juniors, aficionados, trainers and family. (Need not own a registered IALHA horse)

**Individual Associate Membership** is for individuals only and one name is on the card.

**Business Associate Membership:** For a business entity. The business is listed on membership card with the primary person on the second line.

**Youth Associate Membership** Youths may not exceed the age of 18 during the calendar year for which the annual membership exists. Special activities and communications are available to Youth Members.
